## ACT No. VII of 2015

AN ACT to amend various laws to allow the representation of Persons with Disability to various Authorities and Boards.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

Short title.

1. The short title of this Act is the Various Laws (Persons with Disability) (Membership in Various Entities) Act, 2015.

# PART I Amendments to the Housing Authority Act

2. This Part amends the Housing Authority Act, and it shall be read and construed as one with the Housing Authority Act, hereinafter in this Part referred to as "the principal Act".

**3.** Article 6 of the principal Act shall be amended as follows:

(a) in sub-article (1) thereof, for the words "but not more than ten other voting members" there shall be substituted the words "but not more than eleven other voting members"; and

(b) in sub-article (2) thereof, immediately after the words "from among public officers.", there shall be added the words "One of the members shall be a person with disability.".

In sub-article (1) of article 3 of the principal Act for the Amendment of words "not less than four other members appointed by the Minister", there shall be substituted the words "not less than five other members, one of whom shall be a person with disability, all such members being appointed by the Minister".
