On the ratification of the order of financial assistance and pension granting for refugees

The Cabinet of Ministers of Ukraine resolves:

1. To ratify the order of financial assistance and pension granting for refugees (is added).

This order spreads to the citizens indicated in the first paragraph of the second point of the resolution of Verkhovna Rada of Ukraine dated he 24 of December 1993 # 3819 "On the order of putting into effect the Law of Ukraine "For Refugees" (Official Bulletin of Verkhovna Rada of Ukraine, 1994, #16, pages 91).

2. The Ministry of Finances from the 1999 will have to foresee the funds in its projects of the State budget of Ukraine for financial assistance and pension granting to the persons indicated in point 1 of this resolution.

**An order
of financial assistance and pension granting for refugees**

1. To consider an issue connected with the financial assistance granting, refugees may apply with the applications to migration service bodies in Autonomous Republic of Crimea, regions, cities Kyiv and Sevastopol, and to solve the problem on pension awarding - to the Ministry of Labour and social protection of the population of Autonomous Republic of Crimea, the department of social protection of the population of the regions, Kyiv and Sevastopol local administrations by their temporary residence.

2. To get the financial assistance refugees need to give to the migration service body such documents as:

application on one time used financial assistance granting to buy the goods of first need;

application for granting the one time used financial assistance to refund the cost of the trip to the regional point of the refugees temporary settlement, to the region of refugees temporary settlement or to the other place, that refugee had chosen;

copy of the refugee identification, but for the persons indicated in the second paragraph of the 1 point of the resolution,- copy of the reference, that was given out by migration service body, passport or other document that identify person;

copy of migration service body trend - in case of sending refugee to the regional point of temporary settlement of refugees or to the region of temporary settlement of refugees.

3. Basing on this documents the migration service body decide to grant the appropriate financial assistance or to refuse to grant such assistance (appendix 1).

If refugees has all the way of life to live in Ukraine, they may be refused in financial assistance granting.

The decision for financial assistance granting to refugee or the decision for refusing to grant such assistance is made by migration service body during 3 days starting from the day of giving application with all the necessary documents.

4. To get the pension, refugees have to give such documents to the body of social protection of the population by the place of their temporary residence:

application for pension awarding;

copy of the refugee identification, and for the persons, indicated in the second paragraph of the 1 point of this resolution,- copy of the reference, that was given out by migration service body, passport or other document that identify person;

other documents foreseen by the legislation of Ukraine for the pension support.

5. Basing on this documents the body of social protection of the population makes the decision for pension awarding or for refusing in its awarding (appendix 2).

The decision to award pension to refugee or the decision to refuse is made by the body of social protection of population during 10 days starting from the day of giving the application with all the necessary documents.

6. The financial assistance to refugees is consist of one time used financial assistance for buying the goods of first need and one time used financial assistance to refund the cost of the trip to the regional point of the refugees temporary settlement, to the region of refugees temporary settlement or to the other place, that refugee had chosen.

7. The size of one time used assistance for buying the goods of first need is:

one untaxed minimum of the citizens benefit per person, who got 16 years old;

60% of one untaxed minimum of the citizens benefit per child who has 16 years old.

8. One time used financial assistance for buying goods of the first need is paid out in two parts: 50% during five days after the decision for defined financial assistance granting had been made, another part - during ten days after refugee had come to the regional point of the temporary settlement of refugees, to the region of the temporary settlement of refugees or the other place that refugee had chosen, and the registration in interior affairs body.

9. The size of one time used assistance to refund the cost of the trip is defined by the actual costs of the trip to the place of temporary residence, but not more, then the cost of the trip by train in reserved seat coupon.

10. The financial assistance is paid out:

a) for buying the goods of first need:

the first part - by Rada of ministers of Autonomous Republic of Crimea, by the region, Kyiv, Sevastopol local state administrations by the place of temporary residence of refugee to his resettlement to the regional point of the

temporary settlement of refugees or to the region of temporary settlement of refugees;

the second part - by Rada of ministers of Autonomous Republic of Crimea, region, Kyiv and Sevastopol local state administrations by the place of temporary residence of refugees after his resettlement to the regional point of the temporary settlement of refugees or to the region of temporary settlement of refugees;

b) to refund the trip to the regional point of the temporary settlement of refugees, to the region of the temporary settlement of refugees or to another place for residence, that refugee had chosen, - by Rada of ministers of Autonomous Republic of Crimea, regional Kyiv and Sevastopol local state administrations and also the body of migration service is the part of this structure that got a proper application.

If refugee doesn't go to the regional point of temporary settlement of refugees or to the region of temporary settlement of refugees according to the decision of body of the migration service, one time used financial assistance for buying goods of first need is paid by Rada of Ministers of Autonomous Republic of Crimea, regional, Kyiv and Sevastopol local state administrations in full size by the place of its temporary residence.

11. The size of pension to refugees from the number of persons who became a pensioner age that installed in the legislation of Ukraine and also to the invalids of the I and II group is defined according to Article 94 of Law of Ukraine "On the pension support".

In case when the treaty for the pension support of its citizens is concluded, between Ukraine and the state, which citizen is a refugee, or the state of his permanent residence, this person get the pension in order and in size that foreseen by such treaty.

12. The pension to refugees is awarded by the body of the social protection of the population by the place of their temporary residence and is paid out by the installed order from the day of its award during the term of refugee's status activity.

13. The state assistance to refugee's families with children is awarded by the bodies of social protection of the population by the place of their temporary residence according to the Law of Ukraine "On the state assistance to families with refugees". The installed state assistance is not

granted to the refugee's families that residence in the regional points of the temporary settlement of refugees.

14. The bodies of migration service and social protection of the population implement the recordings in refugee's identification and in references given to persons indicated in the second paragraph of the 1 point of this resolution, for granting the proper financial assistance, pension awarding and also they

include a proper information for funds granting to the register (appendix 3).

15. Funds for financial assistance and pension granting are exuded from the republican budget of the Autonomous Republic of Crimea, from the regional, Kyiv and Sevastopol local state administrations of the Ministry of Finances quarterly and by the total year not later then the 20 of the month, that is coming by the final period.

Among this, the report for pension granting to refugees is given by the body of social protection and of the population of the Ministry of Finances and State Committee for Nationalities and Migration quarterly and by the total year not later then the 20 of the month, that is coming by the final period.

The report on a financial assistance for refugees spent is given by the body of migration service of the State committee for Nationalities and migration quarterly and by the total year not later then the 20 of the month, that is coming by the final period (appendix 4).
