Corrigendum

The Government has provided the following information to update its report of  
15 April 1998.

1. Add to paragraph 18 the following text:

It is intended that a Children and Young Persons Bill will be introduced in the legislature in the 1999/2000 session.

2. After paragraph 45 add a new paragraph as follows:

It is intended that a bill to incorporate in Manx law the European Convention on Human Rights will be introduced in the legislature in the 1999/2000 session.

3. After paragraph 58 add a new paragraph as follows:

In November 1998 there were a total of 87 children in care:

Fostered	48
Accommodated in children's homes	18
Undergoing assessment by local social services authorities in England	3
With their own families	15
Old enough to live alone	3

4. After paragraph 60 add a new paragraph as follows:

Legislation to implement the Hague Convention on Protection of Children in Respect of Intercountry Adoption of 1993 is likely to be introduced in the 1999/2000 session, in parallel with similar legislation in the United Kingdom.

5. Add to the end of paragraph 77:

Infant mortality in the island has fallen further to 3.42 deaths per 1,000 live births in 1997 (see appendix I).

6. After paragraph 105 add a new paragraph as follows:

The Police Powers and Procedures Act 1998 came into force on 11 January 1999. It introduces additional safeguards for under-17s who are arrested and in police detention: the police are obliged to inform a parent, guardian or other persons responsible for the child's welfare of the arrest, the reasons for it and where he is being detained. (These rights are in addition to the ordinary rights of a person in police detention.)

7. Replace appendices I-III with the attached new appendices.
